LIMITED WARRANTY

OnTrack Sports, LLC ("Seller") makes the following limited warranties. These limited warranties extend to the original consumer purchaser or any person receiving this product as a gift from the original consumer purchaser and to no other purchaser or transferee.

Limited One (1) Year Warranty

Seller warrants this product and its parts against defects in materials or workmanship for a period of one year after the date of original retail purchase. During this period, Seller will repair a defective product or part, without charge to you. You must deliver the entire product to the OnTrack Sports Service Center. You pay for all transportation and insurance charges for the product to and from the OnTrack Sports Service Center.

Instructions & Warranty Registration

You should read the instructions before using this product. You should also register your product to ensure that your name and address are on file as owners of the product by completing the on-line warranty registration form at the Seller's website at www.acculength.com within ten (10) days after you, or the person who has given you this product as a gift, purchased this product. This is one way to enable Seller to establish the date of purchase of the product, as well as to provide you with better customer service and improved products. Failure to complete the on-line warranty registration form will not affect your rights under this warranty so long as you retain other proof of purchase such as bill of sale.

Your Responsibility

The above warranties are subject to the following conditions:

1. You must retain your bill of sale or provide other proof of purchase. Completing the on-line warranty registration form within ten (10) days after the original retail purchase is one way of providing such other proof of purchase.
2. You must notify the OnTrack Sports Service Center within thirty (30) days after you discover a defective product or part.
3. All warranty servicing of this product must be made by the OnTrack Sports Service Center.
4. These warranties are effective only if the product is purchased in the U.S.A.
5. Warranties extend only to defects in materials or workmanship as limited above and do not extend to any product or parts which have been lost or discarded by you or to damage to products or parts caused by misuse, accident, improper installation, improper maintenance or use in violation of instructions furnished by us; or to units which have been altered or modified without authorization of Seller.
